1 Introduction

1.1 This policy is based on statutory guidance for governing bodies, head teachers, teachers, and educational leaders, aiming to promote social, emotional, and mental wellbeing in children and young people. It aligns with the NICE guidelines and will be reviewed annually by the Board of Trustees.

2 Scope

2.1 This policy applies to all learners at Step Into Learning (SIL), encompassing Relationships Education, Relationships and Sex Education (RSE), and Health Education. It outlines the core themes, implementation strategies, monitoring, evaluation, and accessibility considerations for the PSHE/RSE curriculum.

3 Definition

3.1 PSHE/RSE and Health Education encompass a comprehensive programme designed to promote the social, emotional, and mental wellbeing of learners, equipping them with



knowledge and skills to make informed decisions about their health, relationships, and wellbeing.

4 Policy

Intent

Step Into Learning is committed to providing learners with the knowledge and skills necessary for a happy and successful adult life. The PSHE/RSE curriculum aims to empower learners to make informed decisions, develop resilience, seek help when needed, and contribute positively to society.

Core Themes

The PSHE/RSE curriculum at SIL revolves around four core themes:

- **Healthy lives:** Covering healthy lifestyle choices, sexual health, substance abuse, and financial management.
- **Improving mental health and wellbeing:** Addressing personal wellbeing, resilience, self-esteem, and managing mood.
- **Keeping safe:** Including topics such as online safety, radicalisation, exploitation, and domestic abuse.
- **Positive relationships:** Focusing on healthy relationships, inclusion, sexual health, and celebrating diversity.

Implementation

- The PSHE/RSE curriculum will be regularly evaluated to ensure alignment with national issues and local trends.
- Activities and content will be adjusted based on internal safeguarding and welfare concerns.
- Differentiated (reasonable adjustment) teaching strategies will accommodate learner needs, with emphasis on active learning and engagement.
- Local support and help lines will be incorporated into the curriculum to safeguard learners effectively.

Monitoring and Evaluation

- A core PSHE/RSE curriculum must be developed by all subcontractors, subject to annual review and approval by SIL.
- Quality assurance reviews and termly meetings will facilitate ongoing evaluation and sharing of best practices.

Accessibility

- PSHE/RSE must be accessible to all learners, including those with special educational needs and disabilities.
- High-quality teaching will be personalised, considering the needs of individual learners and reflective of local and regional need.
- Preparing for adulthood outcomes, as outlined in the SEND code of practice, will be prioritised.
